Operation Smile provides free treatment to children and young adults suffering from childhood facial deformities in developing countries. Brisbane plastic and reconstructive surgeon, Richard Lewandowski, first became aware of Operation Smile in 1994 while undertaking specialist training in USA. Richard was privileged to participate in six missions to Colombia, Kenya, Gaza, Philippines, Russia and China in that one year! On his return to Brisbane, Richard and his wife, Sue, decided to set up Operation Smile Australia, focusing mostly on complex craniofacial patients. Highlights to date include: treatment of 29 complex cases in Australia, establishing three craniofacial centres in Manila, Ho Chi Minh and Hanoi and providing further specialist training in Australia for overseas doctors.

Avant Law is a world away from Justin LeGoullon's former position as a specialist nurse in the RBH Burns Ward. Justin's extensive experience as a burns specialist made him an ideal volunteer to attend an Interplast Program in Mount Hagen, Papua New Guinea. **Interplast** sends teams of medical volunteers from Australia and New Zealand to developing countries in the Asia Pacific region to deliver patient treatment and medical training. The Mt Hagen program involved reviewing approximately 90 patients at pre-operative clinic sessions resulting in 32 life changing operations to repair cleft pallets or revise severe and debilitating burns contractures. Justin now has an ambassadorial role raising awareness of Interplast's activities not only within Avant, but also to the broader community.
